
O/o DC(MSME), New Delhi has accorded his kind online approval for **BMUS Fair 2019-20** under 5(A) of the Procurement & Marketing Support Scheme being organised by Bihar Mahila Udyog Sangh, Patna from 14.09.2019 to 18.09.2019 at Gyan Bhawan, Patna.

In view of the above, the online application for the said fair is invited from **eligible Micro and Small Enterprises** from **21.08.2019 to 26.08.2019 upto 04:00 pm**, failing which the application will not be accepted by this office.

Following points are worth mentioning which may be considered by enterprises while applying online:

1. The Units belonging to Micro & Small Enterprises should be registered with MSME Data Bank. Only units who are registered in MSME Data Bank can only apply through online and get the benefits as per PMS guidelines. While registering in Data Bank, the name of this office should be mapped.
2. The scanned copy of receipt towards payment of Stall charges to **Bihar Mahila Udyog Sangh, Patna** of **amount ₹13002.00 only** by eligible Micro and Small Enterprises must be kept ready for **uploading the same during online application through PMS portal** which is mandatory.
3. The Units belonging to Micro & Small Enterprises should have **Current Bank Account** in name of the firm as per Udyog Aadhar Details for getting the reimbursement as per PMS Guidelines otherwise reimbursement can not be processed.
4. The Units belonging to Micro & Small Enterprises can get maximum two number of chance in a Financial Year as per PMS Guidelines.
5. The online claim form must be submitted by the beneficiaries **within one month from end date of said fair**.
