

4. The Bids received in time shall be opened at 03.00 PM on the same day i.e. 15.09.2021 in the Conference Hall of MSME-Development Institute, Patna in the presence of such bidders or their representatives, not more than one for each bid who may wish to be present, if they so desire, at the time of opening of the bids.

5. TERMS & CONDITIONS

(a) The period of contract shall be for one year with effect from the date of award of the contract.

(b) The contract can be terminated earlier by the department without assigning any reasons thereof. The decision of the competent authority shall be binding on the service provider in this regard. No claim for compensation of loss of revenue due to such decision shall be entertained.

(c) The service provider should have a valid GST Registration in accordance with the GST Law.

(d) The service provider should have the required hardware/license to fulfil the requirement of scope of work as described above.

(e) The service provider must have an office located in the city of Patna.

(f) MSEs having valid Udyog Adhaar Memorandum (UAM)/Udyam Registration Certificate shall be eligible for benefits under Public Procurement Policy 2012.


