3. Eligible Agencies interested and capable of fulfilling the AMC for above items may submit their lowest competitive bid/price quotation in the prescribed performa as per Annexure - I addressed to "The Director, MSME-Development Institute, Patliputra Industrial Estate, Patna - 800013" latest by 03.00 P.M on or before 24.03.2021 in a sealed envelope. The envelope should be prominently super-scribed "Bid for Annual Maintenance Contract (AMC) for Computer, Printer UPS etc of MSME-DI, Patna for the year 2021-22.

4. The Bids received in time shall be opened at 03.00 PM on the same day i.e. 24.03.2021 in the Conference Hall of MSME-Development Institute, Patna in the presence of such bidders or their representatives, not more than one for each bid who may wish to be present, if they so desire, at the time of opening of the bids.

5. TERMS & CONDITIONS

- (a) The period of contract shall be for one year with effect from the date of award of the contract.
- (b) The contract can be terminated earlier by the department without assigning any reasons thereof. The decision of the competent authority shall be binding on the service provider in this regard. No claim for compensation of loss of revenue due to such decision shall be entertained.
- (c) The service provider should have a valid GST Registration in accordance with the GST Law.
- (d) The service provider should have the required hardware/license to fulfil the requirement of scope of work as described above.
- (e) The service provider must have an office located in the city of Patna.
- (f) The successful bidder will have to deposit a "Performance Security" of Rs5,000/- (Rupees five thousand only) in the name of "PAO (MSME), Kolkata" within 10 days of award of the contract. The Performance security will be forfeited for breach of any of the terms and conditions of tender, besides it may be blacklisted. Performance security will be released to the supplier without any interest, whatsoever, after satisfactory completion of the contract.
- (g) MSEs having valid Udyog Adhaar Memorandum (UAM)/Udyam Registration Certificate shall be be eligible for benefits under Public Procurement Policy 2012.
- (h) Payment shall be made against bill after satisfactory completion of work on quarterly basis. However, advance payment not exceeding the amount payable for six months under the contract may be considered against the bank guarantee.
- (i) The Competent authority reserves the right to amend/withdraw/relax/modify any of the terms and conditions contained in the tender notice.
- (j) The Competent authority reserves the right to accept or reject any or all of the bids/quotations without assigning any reasons thereof.
- (k) Bids incomplete, unsigned and received after the specified date and time shall not be entertained.
- (l) In case of any disputes, the decision of the competent authority shall be final and binding on the service provider.
